Respected Sir,

Association of Scientific & Technical Officers (ASTO) of ONGC is only recognized representative body of the 21000 strong executive community of ONGC. ASTO has always played a major role in the phenomenal growth of the company over several decades and is an effective interface between employees and Govt. of India in order to achieve energy security for our country.

Sir, employee at ONGC are gearing up to meet ever increasing energy needs of the nation and are fully committed to Hon'ble Prime Minister's goal to reduce oil import bill by 10% by year 2022.

We would like to bring to your kind notice an issue that pertains to nearly 33,000 employees working in ONGC and about 10,000 employees who have superannuated since February, 2015. This is related to Long Service Reward Scheme which was earlier introduced in ONGC to recognize the contribution of employees who have served ONGC with utmost sincerity and dedication. However this scheme was discontinued in ONGC abruptly with effect from February' 2015.

Sir, such scheme was also introduced in other oil PSUs and there too was stopped w.e.f. February, 2015. However, in downstream oil PSUs, it has been restarted and has been benefiting their employees since last one and a half years. However at ONGC it is yet to restart. In fact employees of ONGC, a Maharatna PSU, are superannuating after serving this great organization for more than 35-40 years of service without any recognition of their contribution.
